**Expenditure Incurred under Mission Management for the period from
01.07.2019 to 31.10.2020**

- The SLEC has noted and approved the expenditure incurred under Mission Management.

The Chairman, SLEC, MIDH, Telangana has issued following instructions during meeting:

1. Field level Pack houses may be encouraged through Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS). Accordingly, a letter may be addressed to Commissioner, Rural Development Department, Telangana for inclusion of Field level pack houses as a component under MGNREGS.
2. It is observed that none of the Post-Harvest Management infrastructure proposals (Cold Storage) of our state are availing interest subvention facility under Central sector scheme of financing facility under 'Agriculture Infrastructure Fund' due to less percentage of interest subvention (i.e., 3% only) in the scheme. Hence, a letter may be addressed from State PMU, PM Kisan, Telangana (i.e., Agriculture Dept) to the Secretary, Department of Agriculture, Cooperation & Farmers Welfare, Govt., of India with a request to increase interest subvention to 7% under Central sector scheme of financing facility under 'Agriculture Infrastructure Fund'.
3. Telangana state stands first in Turmeric production in the country and produce is being exported to other states of India and South Asian countries. The farmers are not getting remunerative prices which is leading to agitations by the Turmeric growers. Establishment of ayurvedic related processing units like Patanjali industries will help in better price realization to the farmers. Hence take up a study on **scope and viability for establishment ayurvedic related turmeric processing units in Telangana state with special reference to Patanjali industries** by any reputed organizations.
